F. PRICE

Prices for the new period are set forth in the Symphony Tables Price List #1005 effective October 1, 2005. Prices are subjected to the discounts as follows:

DISCOUNTS FOR PRODUCTS TO BE DOCK DELIVERED ONLY

48% discount for orders from \$1 - \$ 10,000
51% discount for orders from \$10,001 - \$25,000
54% discount for orders from \$25,001 - \$50,000
55% discount for orders from \$50,001 - \$100,000
56% discount for orders from \$100,001 - up

The only items that have been approved and are included in the agreement are as follows:

Cafeteria Furniture: Mobile tables on rollers with or without benches or stools; round and rectangular cafeteria tables without benches or stools.

School Furniture: Student desks, chair desks/tablet arm chair, stools; single unit pedestal teacher's desk; study carrels; stacking chairs/student chairs/folding chairs; classroom activity, computer, folding, and training tables and accessories, such as ganging devices, electrical/data components and storage dollies.

Seating: Wood, metal or ergonomic seating which may include, but not be limited to, executive, managerial, task, operational, sold, side, occasional, stacking, conference, and theater/stadium type seating. Products must meet or exceed ANSI/BIFMA requirements.

Any items that can be purchased from a competitively bid state contract with the Office of Purchasing and Travel shall not included in this agreement.

Cost of design fees are not included in this agreement and must be negotiated with the buying entity if needed. This agreement is for where the net amount, after discount, shall not exceed \$500,000.

Catalogs and Price Lists may be obtained from the Contractor.

G. TRANSPORTATION

F.O.B. Destination: Delivered and Installed shall mean freight and installation cost prepaid delivered and installed inside any agency within the State of Mississippi with all charges for transportation and installation paid by the Contractor. Dock Delivery shall mean freight charges paid by the Contractor to the dock only. No installation is included.

H. TERMS

Net thirty (30) days.
